In some cases, we will not be able to make all funds that a member deposits by check available on the same business day as the day of deposit. Depending on the type of check deposited, funds may not be available until the second business day after the day of deposit. However, the first \$225 of a member's deposit will be available on the day the deposit is made. Currently that amount is \$200.
